Upon receipt of your signed quotation and the full payment (which includes your connection fee and security deposit), Sembcorp Siza Water will commence with your connection which should take up to 10 working days for a Standard Connection. Please note, from date of installation all applicable charges will be levied as per our tariff of charges.

- **A signatory who is:**

- An unemancipated minor is to be assisted by his / her guardian.
- Anyone married in community of property.
- Anyone signing on behalf of a company, close corporation or other artificial person or organisation is to state the capacity, in which he signs and shall, produce his authority to sign.

- **Responsibility for payment of account:**

By signing below, you or the person / Company on whose behalf you are signing for, accepts responsibility for the payment of this account as and when payment is due.
