If a customer no longer requires a supply of water, Sembcorp Siza Water requires at least fourteen days written notice (from the date of receipt by Sembcorp Siza Water) of their wish to discontinue their account.



If the information concerning the new occupier is not indicated in the Change of Occupant application, Sembcorp Siza Water shall have the right to include the recorded owner of the property in question, in the customer inventory as the new occupant and make the appropriate water and sanitation charges.

If we do not receive such notice, we may charge you for the supply of water services until we are notified by a new occupier.

If any supply has been turned off for a continuous period of 30 days, Sembcorp Siza Water may terminate the contract of supply following consultation with the property owner.

Should you default on your account payments, Sembcorp Siza Water will be compelled to hand you over to collection agents and this may result in you being black listed with the Credit Bureau. This information will also be made available to other credit grantors where the persons may apply for credit facilities.
